

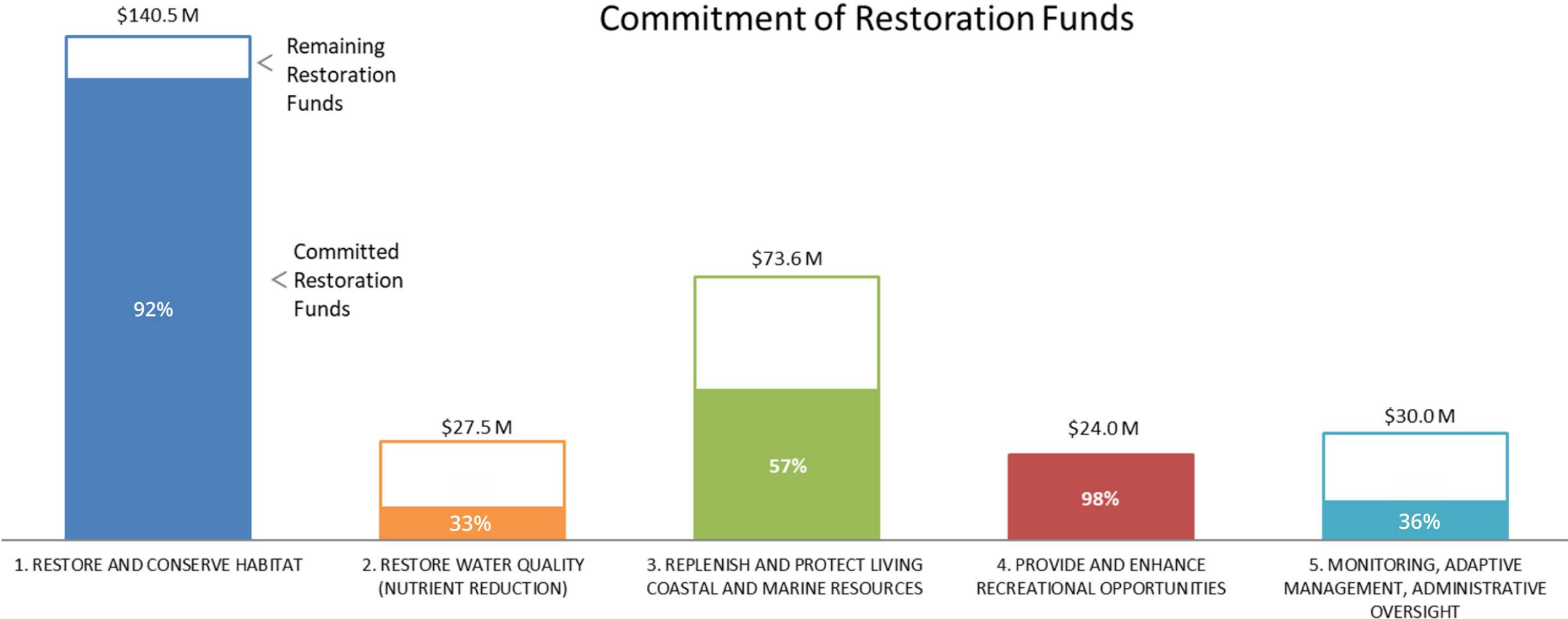

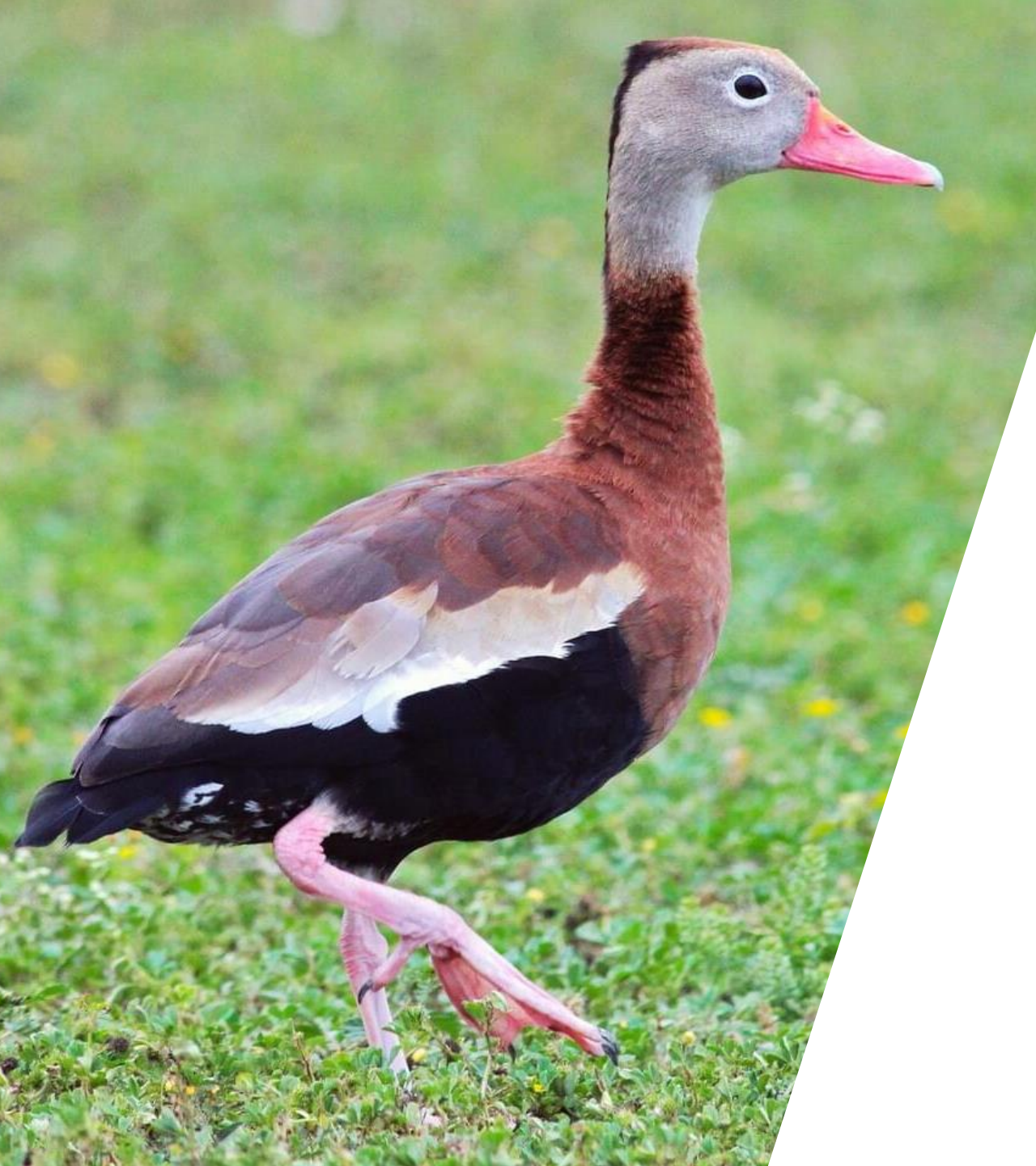
NRDA ANNUAL MEETING UPDATE

**Mississippi TIG Restoration Plan 4 and
Environmental Assessment:
Wetlands, Coastal and Nearshore Habitats;
Nutrient Reduction (Nonpoint Source); and
Provide and Enhance Recreational
Opportunities**

Final Plan released January 3, 2024

Seven projects were selected for implementation

- ❖ Coastwide Habitat Acquisition (\$5,000,000)
- ❖ Living Shoreline Bulkhead Alternative (\$3,000,000)
- ❖ Living Shoreline Bulkhead Alternative (\$3,000,000)
- ❖ Back Bay Davis – Davis Bayou Nutrient Reduction (\$2,500,000)
- ❖ Big Cedar Creek – Rocky Creek Nutrient Reduction (\$2,500,000)
- ❖ Jourdan River Boardwalk (\$2,118,000)
- ❖ Shepard State Recreational Enhancements (\$735,000)

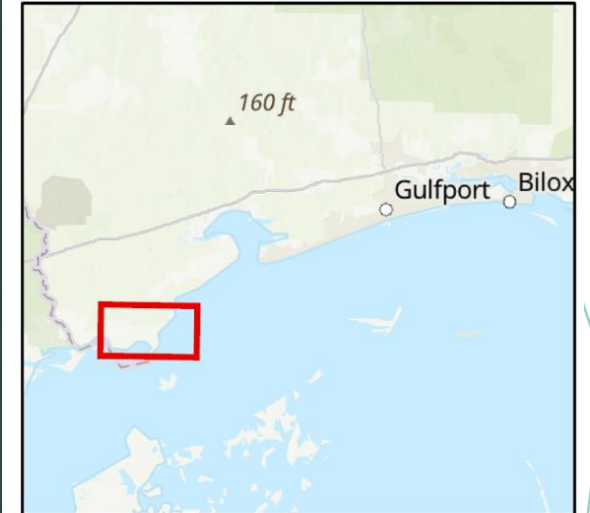
